APA Style requires that references include the following information (example: see image below): Author name; The publication date in parentheses which includes the year, month, and day; Title of the document; Title of the publication; Volume number

How to Cite Online Sources - Details With APA and MLA

In-text references must be included following the use of a quote or paraphrase taken from another piece of work. In-text citations are citations within the main body of the text and refer to a direct quote or paraphrase. They correspond to a reference in the main reference list.

Identify the author and title for each source. For every source you plan to use in your research paper, write down the author and title. If there are multiple authors, write them down in the same order as they appear on the title page of a book, or in the byline of an article.

Use parenthetical documentation. This means placing the source and page number directly after the quote or fact cited in your essay. Place the author's last name and the page number of the quote or fact in parentheses after the quote.

Parenthetical Documentation - using () to identify your source In the MLA format, parenthetical or in-text documentation, is used to briefly identify the sources of information you have borrowed in writing your paper. Parenthetical documentation should be integrated smoothly into the text of your paper, rather than listed separately.

Published sources, including books, should list author (or compiler or editor) first, followed by the title, publisher, publication place and date, and page numbers. List multiple authors in the same order as shown on the title page unless there are more than three authors, in which case, include only the first author followed by et al.
